## TERMS AND CONDITIONS

This Agreement details the licence we grant to you and governs your use of the Fiction Express subscription service (the "Service"). By accessing the Service, you agree on behalf of yourself or your school ("School") to the terms below, regardless of who has paid for the subscription, whether it is you, your School or another party, for example, your Local Authority.

### Holder

The owner of the Service and the Fiction Express website (the "Site"), [www.fictionexpress.com](http://www.fictionexpress.com) is FICTION EXPRESS EDUCATION SL ("FICTION EXPRESS"), with tax identification number B-65689804 and registered office at Carrer Estruc 9, 08002, Barcelona, Spain.

If you have any questions about these terms, you can contact FICTION EXPRESS via the 'Contact' page on the website, or by sending an email to [info@fictionexpress.com](mailto:info@fictionexpress.com) or by letter to FICTION EXPRESS, at the above address given, or by telephone on +34 930 130 130.

### Access to the Service

You can gain access to Fiction Express in two ways: (a) Purchase of a school licence; (b) Purchase of a textbook or document and/or similar material with a unique Fiction Express registration code distributed through one of our distribution partners (valid only in certain countries).

### Acquisition of School licences

In your School registration, you choose a resource manager within your School who will be responsible for giving access to additional users (teachers). Each teacher, who is granted access to the resource, manages their own classes and students through their teacher panel. You are responsible for all use of the Service in connection with your subscription and for preventing unauthorised use. All users must be part of your organisation, i.e. head teacher, teachers and students. You must ensure that any user using the Service pursuant to your subscription complies with the terms of this Agreement and all reasonable user terms available on the Site.

The subscription is for a licence for the School, which allows it to be accessed by all teachers and students of the School at any time and in any place on any device connected to the Internet, whiteboards, laptops, tablets, smartphones, etc. The number of students and languages contracted will be governed by those confirmed in this agreement.

The basic subscription to Fiction Express ("Fiction Express Live") includes access to the following content and features:

- Eighteen interactive "living" e-books per school year (six e-books per term), each delivered in five weekly chapters posted on our website [www.fictionexpress.com](http://www.fictionexpress.com).
- Individual or class vote of all registered users on the choices at the end of each chapter.
- Online reading comprehension questions at the end of each chapter.
- Weekly notes for teachers and guidance for all registered teachers.
- Teacher dashboard to track student activity (reading, voting, reading comprehension questions).
- During the 5-week "lifespan" of each book, access the microblog or forum to share ideas and comment with the author.

In addition, you can subscribe to our top tier "Fiction Express Gold Reader" to gain access to all previously published books on the platform where readers can compare their vote with the option that won when the book was initially written. These books also include resources for teachers (although the format may

differ from the "live" books) and online reading comprehension questions.

### Conditions of Service

- a. These terms and conditions (including the documents referred to in them) contain the entire terms on which we provide the Service to you. They supersede any prior promises, representations, undertakings, commitments or implications made. Where you are a private consumer, nothing in these terms and conditions will detract from your statutory rights.
- b. Your subscription starts on the day we send an email notification from FICTION EXPRESS. It is your responsibility to ensure that the details are passed on to the relevant person(s) in your school or library to facilitate access to the Site.
- c. The fee for your subscription (the "Fee") is calculated annually on the anniversary of the commencement of your subscription (unless otherwise stated) and is payable by the method of payment requested by FICTION EXPRESS. FICTION EXPRESS shall not be obliged to provide the Service until the Fee has been paid. Your subscription will automatically renew unless you confirm that you do not wish it to do so and agree to pay the fee for the following year. If you do not pay the fee during a subsequent year, FICTION EXPRESS may suspend your access to the Service until your fee is paid.
- d. Access to the Service is only provided to you on condition that you pay the Fee (if you are an individual member) or that you are a duly authorised employee of an institution that has paid the Fee.

### Conditions of use of the Account

- a. You acknowledge that you have provided FICTION EXPRESS with accurate and complete registration information and that it is your responsibility to update FICTION EXPRESS of any changes to that information (including your email address) through the user panel on the Site.
- b. You may not rent or lease access to the Service and you may not provide access to third parties outside the organisation that subscribes to the Service (or allow any other unauthorised person to provide access).
- c. If FICTION EXPRESS reasonably believes that your subscription to the Service is being used in any manner that is not permitted by this Agreement, FICTION EXPRESS reserves the right to terminate access rights immediately upon notice to you and block your site's access to the Site.
- d. Your subscription to Fiction Express is not inheritable or transferable. If you allow another person to use your account, you are responsible for all acts of that person in connection with FICTION EXPRESS and the terms of use.
- e. You must not use the Fiction Express website in any way that causes, or is likely to cause, the website or access to it to be interrupted, damaged or impaired in any way.

### Rights on Fiction Express material

You may not use any Fiction Express information, data, names, images, logos or icons ("Materials") from

personal information, we cannot guarantee its absolute security.

- b. If you believe that there has been a breach of security, such as disclosure, theft or unauthorised use of your access date, you must notify FICTION EXPRESS immediately by sending an email to [info@fictionexpress.com](mailto:info@fictionexpress.com).
- c. Account information for Fiction Express subscribers is password protected so that you and only you have access to this personal information. You can edit your account information in the user panel on the Site.
- d. We recommend that you do not divulge your password to anyone. It is your responsibility to ensure that students at your School keep their passwords secure. FICTION EXPRESS will never ask you for your password in an unsolicited phone call or in an unsolicited email. Also remember (and remind your students) to log out of your Fiction Express account and close the browser window when you have finished your activities when using a public computer. This is to ensure that others cannot access your personal information and correspondence if you share a computer with another person or if you are using a computer in a public place such as a library.

### Suspension and cancellation of the account/suspension.

FICTION EXPRESS has the right to cancel your subscription to Fiction Express and close your account if you breach these terms and conditions or the conditions set out on the Fiction Express website. We may also terminate your account if you fail to pay your subscription fee in accordance with the payment terms specified in the relevant invoice.

The moment you cancel your subscription, you will lose the time remaining on your Fiction Express subscription.

### User contributions

- a. FICTION EXPRESS may invite you to make, share or submit your own or your students' stories, illustrations or other contributions. These Terms set out the rules governing how you do this and how FICTION EXPRESS may use your contribution.
- b. Any copyright in your or your students' contribution will remain with you or your student. In this agreement, you grant FICTION EXPRESS the right to use the material in your or your students' contribution in any way you may choose free of charge for an unlimited duration and worldwide and regardless of the medium used, i.e. whether on the Internet, on television or via mobile distribution, etc. This means that you grant FICTION EXPRESS the right to use, copy, present, reproduce, display, edit, integrate, license and distribute the material you have created. You also allow FICTION EXPRESS to use the name that you submit in connection with such content if they so choose. These rights of FICTION EXPRESS apply to both commercial and non-commercial use.
- c. You confirm that your or your students' contribution is your or your students' original work, is not defamatory or unlawful and does not infringe the rights of any other person (including privacy rights) and that it complies with the Terms and Conditions. You further confirm that (i) your contribution is made in your personal (rather than commercial) capacity or that of your students and that such



the Fiction Express Site unless it is clear on the website that this is permitted. This means that you may not copy, distribute, disseminate, broadcast, sell, publish, post or distribute those Materials to any other person, or commercially exploit any of the content without the written consent of FICTION EXPRESS Nor may you change, revise or replace any of the Materials found on the website, either in whole or in part.

### Guarantees

FICTION EXPRESS will use its skill to make the Service available to you and to ensure its continued availability during your Subscription. However, due to the nature of the Internet and computer software and hardware, errors and omissions occur and FICTION EXPRESS makes no other warranties with respect to the Service. In particular, you should not assume the accuracy of the information and FICTION EXPRESS does not warrant that the Site is free from infection by viruses or anything else that has contaminating or destructive properties. All implied warranties are excluded from this Agreement to the extent that they can be excluded as a matter of law.

### Limitation of liability

- a. FICTION EXPRESS will use its best efforts to resolve incidents with the Service during the Subscription. You agree that your sole recovery for damages you incur, and your exclusive remedy, will be limited to direct damages actually incurred up to an amount equal to the fee actually paid or payable in connection with your use during the relevant term of the Service. Where you are still in a trial period, your sole remedy shall be to terminate your use of the Service.
- b. To the maximum extent permitted by applicable law, in no event will FICTION EXPRESS be liable for any damages arising out of the use or inability to use the Service (including, without limitation, damages for loss of business profits, business interruption, loss of business information or other pecuniary loss), even if FICTION EXPRESS has been advised of the possibility of such damages. In any event, FICTION EXPRESS's total liability to you under this Agreement or with respect to the Service shall be limited to the amount actually paid for the Service.
- c. contribution does not unfairly promote or advance any commercial activity and has not been contributed for commercial purposes, (ii) the consent of any person who is identifiable in your contribution or the consent of their parents/guardians if they are under 16, and that your students have the consent of their parents/guardians to accept these Terms if they are under 16.

- d. The Site contains a book forum within which users can post contributions. All user contributions will be reviewed. These Terms set out the rules governing the use of the Fiction Express book forum.
- e. You warrant that the content you and your students submit to us is not obscene, threatening, harassing, libellous, defamatory, deceptive, fraudulent, invasive of another person's privacy, offensive, libellous to any person or illegal. You agree that neither you nor your students will (i) post content that is deliberately intended to annoy or harm other users; (ii) use the Site to post or transmit content that victimizes, harasses, degrades or intimidates an individual or group of individuals on the basis of any impermissible classification, including, without limitation, religion, gender, sexual orientation, race, colour, creed, ethnicity, national origin, citizenship, age, marital status, military status or disability; (iii) post or transmit any content that contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of the Site or any computer software, hardware or telecommunications equipment; (iv) upload or otherwise transmit any content, or take any other action with respect to your use of the Site, that would constitute, or encourage, criminal conduct or give rise to civil liability; or (v) use the Site for commercial purposes, including, without limitation, sending any material to solicit funds or to promote, advertise or solicit the sale of any products or services.

### Integrity

These Terms and Conditions supersede all previous agreements, understandings, and commitments between the parties, and constitute the entire agreement between FICTION EXPRESS and you. If any of the clauses of the Terms and Conditions are considered void or null and void, they shall be deemed not to have been put in place, with the rest of the contract retaining all its binding force between the parties.

### Applicable law and jurisdiction

These Terms and Conditions shall be governed by and construed in accordance with the laws of Spain and, expressly waiving any other jurisdiction that may correspond to them, expressly submit to the Courts of the city of Barcelona for any legal claims that may arise from them.
